26/15 REPORT FROM IW COUNCILLOR

Cllr Downer reported that he had allayed the concerns of a resident of Paddock Close about the felling of trees in that area.

Island Roads are proposing to have a blitz on potholes.

Cllr Downer has spoken to Island Roads regarding the height of the hedge in the car park, and expressed the view that it should be lowered. He will pursue this issue.

Cllr Downer had discussed the poor drainage at Beacon Alley with a resident of that area. Island Roads do not intend to take action until the road is resurfaced in 2016, but he will press to bring that date forward.

12. **27/15 QUESTIONS FROM CURRENT MEETING**

Standing Orders were suspended to allow a member of the public to point out that, in the recent accident at the junction of Newport Road/West Street, the trailer concerned did not actually mount the pavement, though its bodywork did overhang it.

It was reported that there had been an increase in speeding incidents in the Village. It was felt that traffic lights should be considered as a solution to this problem, and Cllr Downer agreed to pursue this with Island Roads, who had confirmed that a 20mph speed limit is proposed when the main road is resurfaced.
